In accordance with its notice obligations under Terms and Conditions, BNP Paribas Issuance B.V. - (iv) The "**Redemption Date**"/"**Optional Redemption Date**" shall be **26 March 2025** (i.e. 4 Business Days following the Valuation Date).

Capitalised terms not defined in this notice shall have the same meaning given to them in the conditions of the Securities or in the Base Prospectus, as applicable.
